Sub.:- Consolidation of SSAs into Business Area: Regarding Administrative Implementation.
Ref.: This office letter of even no. 29 dated 05.10.2016.

Vide above referred letter, the administrative implementation of Business Area, including the Reporting Structure of the BAs Head and Merged SSA Heads, was issued. The roles and responsibilities of BAs and Merged SSAs, as per Corporate Office instructions, was also enclosed as Annexure I, with the said letter.

References are being received in this office, about the financial powers of the SSA Heads, in view of certain roles and responsibilities bifurcation, between BA and Merged SSA, as proposed in Annexure I of the above referred letter.

It is hereby clarified that the above order, under reference, is only for the administrative implementation of the BA concept in MH Circle, envisaging the re-organization of the SSAs as BA Head SSAs and Merged SSAs. The implementation of roles and responsibilities among BA Head SSA and Merged SSAs, as envisaged in Annexure I, shall be notified subsequently. Financial powers of Heads of Merged SSAs, as also of BA Heads, shall be as per the existing orders in place, before issue of the above referred letter of administrative implementation of BA in MH Circle, till further orders.

It is also requested to modify the Reporting Structure of Heads of Merged SSAs and Heads of BAs in ERP, by ERP-HCM Administrator of the concerned SSA. Prior to modifications in organization structure and change in reporting, it is to be ensured that the pending items in PRD and ERP-ESS are cleared by the respective earlier reporting officers. Reporting pattern in the ORG structure shall be carried out by ERP-HCM administrator of SSAs.
