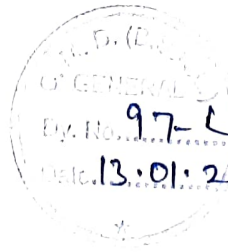

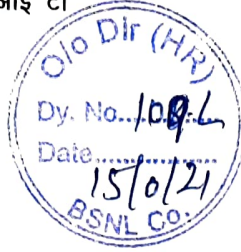

Dear Purwar Sir,

This is reading reconciliation of Exgratia amount payable to VRS-2019 optees of BSNL/MTNL. In this connection, reference is invited to this office DO No. 15-37/2020-21/BA&IT/650 dated 17.09.2020 addressed to Director (HR), Corporate Office, BSNL was requested on following steps to be taken by BSNL Units-

- (i) Matching of data in ERP with SAMPANN data provided by DoT HQ/CGCA
- (ii) Reconciling the cases wherein there is difference in the payable ex-gratia amount by interacting with respective CsCA for which respective BSNL circles may depute their staff to O/o CsCA.

Further, it is brought in notice by various CsCA offices that the amount of Ex-Gratia payable could not be reconciled and finalized due to the following reasons:-

- 1- Data from BSNL units is still awaited for verification in CCA offices
- 2- Annexure B & D not submitted by BSNL units to respective CsCA offices.
- 3- Correction & reconciliation of Ex-Gratia calculation is pending to be done by BSNL Units. Annexure B & D after re-verification of data yet to be received from BSNL units.

Hence, I request you to kindly direct executives concerned to pay adequate attention towards the matter personally and direct SSAs/BSNL units for submission of corrected Annexure B & D to CCA offices along with necessary action on the points 01 to 03 above on priority for payment of ex-gratia in time.
