Sub: Consideration of Temporary Status Mazdoors(TSMs) regularised on or after 01.10.2000 and absorbed in BSNL w.e.f. 01.10.2000 and covered under Rule 37-A of CCS(Pension) Rules for granting 1st NEPP at par with DOT absorbed regular employees- reg.

Sir,

The undersigned is directed to refer to your office letter No. A/PPE-11/Details of TSM/CCS (Pension) rules/24 dated 23.06.2018 on the subject cited above whereby details regarding TSMs regularised on or after 1.10.2000 has been furnished in respect of Maharashtra Circle with an aim to assess the financial implication in considering their benefits under NEPP as DOT absorbed employees.

In this regard, it is stated that the data furnished by your office is not meeting the requirement as laid out vide BSNL CO's letter of even No. Dated 21.11.2017 (copy enclosed). Two things were required as:-

- i) Total No. of employees who were TSM on or before 30.09.2000 and who were regularised as RM on or after 01.10.2000 in terms of DOT letter No.269-94/98-STN-II dated 29.09.2000 [key: these TSMs have been issued Presential Order subsequently to their appointment as RM]
- ii) The financial implication in considering their time bound pay upgradation under NEPP as DOT absorbed employee. This should include the amount of enhanced pension contribution.[key: DOT absorbed employees are entitled for first time bound upgradation in four years unlike others in eight years].

It is, therefore, requested to furnish the same immediately for submission to the competent authority, without any further delay.
