Sub: Compliance of provision of applicable Labour Acts - Maintenance of records regd


It is observed that most of the decisions of labour authorities on the contract workers' complaint cases, have gone against the BSNL mainly because of non- availability/ non- production of records related to contract workers engaged by it through various contractors. This has not only increased the financial liability but it has also brought disrepute to BSNL. In this context, attention is drawn towards the clause No.29 /Chapter-VII of Contract Labour (Regulation & Abolition) Act 1970, vide which principal employer is obligated to maintain the records/registers in the forms, as prescribed.

It is therefore requested to issue advisory to all field units to maintain the records of contract workers engaged by it through contractors, as per prescribed forms given in Contract Labour (Regulation & Abolition) Act, 1970. In particular, it is advised that record, in the following forms, related to contract workers must be invariably obtained from the contractor (under his signature), prior to making payment of each bill. An undertaking to this effect must be given by the BSNL field officer.

1. Form-XIII-- (Register of workmen employed by the contractors).
2. Form-XVII -- (Register of wages).

A copy of above 'forms', as available in Contract Labour (Regulation & Abolition) Act 1970, is attached herewith.
