The leave, if any, requested by the official under transfer should not be allowed/sanctioned by SSA/Unit head, without the approval of Circle Office, Mumbai.

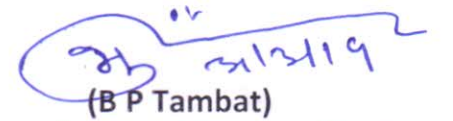
As the official(s) who is/are under transfer on his/her own cost is not eligible for transit period/TA/DA etc. should join their place of posting immediately on their relieving.
