Sub:- Holding of LICE [JTO (T)] in BSNL under 50% quota for VY 2017-18, scheduled on 28.04.2019 (Sunday) ---constituting of Examination co-ordinator/Observer/ Examination team & Venue information reg...

I am directed to refer to the notification of above said examination to be held on 28.04.2019 (Sunday). In this regard, it is hereby intimated that:-

- i) The concerned circle shall constitute an examination conducting team with suitable nos. of members, wherein an Executive/Officer not below the rank of **GM/ JT.GM/DGM/SE** (preferably from HR/Admin sections) would be the **Examination co-ordinator**.
- ii) The Examination Co-ordinator then shall nominate the name of **Examination Observer** to form the Examination conducting Team with suitable nos. of members as felt necessary. The Examination Observer shall be not below the rank of **AGM / DE / EE**. The observer shall have a team. The number of team member should be in accordance with number of candidates i.e. for around 50 candidates, one team member should be there. Team member should not be below the rank of SDE or equivalent.
- iii) **The Examination co-ordinator/Observer shall make all correspondences from an authenticated Email-id, solely for Examination purpose.**
- iv) The members of the constituted team shall be amongst the executive/non-executives working in the Examination city only.
- v) The constituted team shall prepare a detailed schedule of execution as per the local need and must have a dated/timed checklist assigning the responsibilities of each of the members. The said execution schedule & the check list thereof should be signed by all the members along with the Examination Co-ordinator/Observer in record/file.
- vi) The Examination Co-ordinator/Observer shall submit a report to the Recruitment Branch, BSNL CO within 02(two) days of the examination to **Email IDs:- agmrectt1@gmail.com and dmrectt1@gmail.com.**
- vii) The duty of entire constituted team shall be in addition to his normal duties, without any extra remuneration. **However, all the members shall be entitled to Honorarium etc.,**

The Examination Co-ordinator/Observer are to be directed to conduct the following duties and report the shortcomings, beyond his/her control if any, to the GM of the SSA/ Circle or to Recruitment cell of BSNL Corporate Office as well as to the concerned person of the Examination conducting Agency to mitigate the same.

1. Auditing of the Examination Centre proposed by the Examination Agency in the Telecom Circle one day prior to the scheduled date of examination.
2. The Examination Co-ordinator/Observer should scrutinize the proposed Examination Centre on the following parameters :-
 - a) Security of the Examination Centre.
 - b) Prevention of violence/malpractice etc.
