Approval of CGMT, MH. Circle is hereby conveyed for renewal of empanelment and new empanelment of the below mentioned hospitals in your SSA for the medical treatment to BSNL employees covered under BSNL MRS up to **31/03/2021**. This is issued in response to your letter under reference above. The rates for treatment should not exceed CGHS rates issued by the Ministry of Health & Family Welfare, Govt. of India time to time. This approval is issued as per BSNL Corp. Office guidelines vide letter No. BSNL/ADMN/I dt. 22/04/2003.

The SSA Head is requested to enter into an agreement annexing the required documents which are essential for settlement of medical bills. Such an annexure has already been issued / circulated vide this office letter No. A/ Admn-II/Medical Facility/Guidelines/2011-12/88 dated 14/03/2012.

Unless the agreement is signed by both the parties ( BSNL and Hospital), the hospitals will not be considered as empaneled. If the empaneled hospital is not able to furnish IT Exemption Certificate issued by the Income Tax Department, TDS may be deducted from the payable bill amount.

After agreement is made, the empanelment of the hospitals may be conveyed to this office with copy to CAO(OP & MKTG) O/o CGMT MH. Circle Mumbai and also uploaded on SSA's website.


