

Unless the agreement is signed by both the parties (BSNL and Hospital), the hospitals will not considered as empaneled. If the empaneled hospital is not able to furnish IT Exemption Certifical issued by the Income Tax Department, TDS may be deducted from the payable bill amount.

After agreement is made, the empanelment of the hospitals may be conveyed to this office with copy to CAO(OP & MKTG) O/o CGMT MH. Circle Mumbai and also uploaded on SSA's website.
