**Subject: Clarification regarding level of Dy Liaison Officer in SSA/ Telecom District.**

The issue regarding nomination of Dy Liaison Officer in SSA/ Telecom District, has been under consideration of this office. As per Government guidelines, an officer in the rank of Deputy Secretary is nominated in each Ministry, subordinate office, PSU etc. to ensure compliance of reservation orders issued in favour of SCs/STs and also ensuring prompt disposal of grievances etc. Similarly, in BSNL, DGM and above level officer is nominated as Liaison Officer in each Circle to ensure compliance of reservation orders issued in favour of SCs/STs, inspection of reservation rosters, liaison with Management for settlement of grievances of SC/ST employees and also function as co-opted member in all CPCs conducted in each Circle.

It is stated that in BSNL, there are three layers of functioning i.e. Corporate Office, Circle Office and SSA/ Telecom District. In all three levels recruitment, promotion are done by respective unit for defined cadres and rosters are maintained separately. In this regard, to ensure compliance of Government directions on reservations, CLO is appointed at Corporate Office, LO and Dy LO are nominated at Circles and SSAs/ Telecom Districts respectively. To make the instructions issued by BSNL SCT Cell vide letter No.25-1/2006-SCT/2 dated 5.1.2006 more clear, it is intimated that the Liaison Officer at Circle Office and Dy Liaison Officer at SSAs office both will be at least at the rank and status of DGM.

In case no DGM level SC/ST Officer is available in any SSA/ Telecom District, the AGM level officer may be nominated as DY Liaison Officer till availability of DGM level officer under intimation to this office mentioning the reason clearly.
