
In continuation of the above letters it is intimated that candidates presently working in Non Recruiting Units and O/o CE Civil/ CE Electrical/ Chief Architect located in Mumbai area may submit the applications duly filled to their controlling officers. The controlling officers in turn may scrutinize the application vis-à-vis Recruitment Rules of Telecom Mechanic -2012 circulated along with the notification dated 06/06/2019, ascertain the eligibility after checking the Service Book, update/ e-verify data in ERP/ SAP and send the application along with Annexure E (enclosed with the notification dated 06/06/2019) to the AGM (Admn), O/o CGMT MH Circle Mumbai.

The candidates also have to submit willingness for appointment in Raigad SSA if qualified in the exam. The same may also be forwarded to AGM (Admn) Circle Office Mumbai along with the application.

The AGM (Admn) Circle Office has been designated as a Nodal Officer for the candidates working in the above mentioned units in Mumbai. AGM (Admn) may issue Hall Tickets to the eligible aspiring candidates in accordance with the terms and conditions mentioned in the notification and also send a list of candidates in Annexure E of the notification to AGM(DE &R), Circle Office Mumbai, under intimation to GMT Raigad.

It may be noted that last date of submission of application by the candidates is 14th August 2019. The controlling officers are requested to send the applications along with relevant documents latest by 16th August 2019 and AGM (Admn) Circle Office Mumbai may send the required information to this office by 18th August 2019.
