
During the meeting with CCA MH & Goa it was pointed out by CCA that there is abnormal delay in forwarding the pension cases by BSNL Units. Furnishing of reply to the queries/clarifications/documents sought by CCA while processing pension cases are also abnormally delayed. The list of officials/officers of MH Circle who are going to retire on superannuation in the month of Aug-2019 to Jan-2020 is attached in Annexure herewith. All concerned Controlling Units are instructed herewith to take necessary action in advance i/r/o preparation of pension papers of the officials/officers and further submission of the same to concerned CCA Units.

On the subject, the directions/guidelines issued by this office vide letter No. A/STB/AE-20/SDE/Vigilance Clearance/2019/49 dtd 25.06.2019 (copy enclosed) may also be referred while processing the pension cases.

This office is in receipt of letter No. CCA/MH/PEN/CPMS/52 dtd 22.07.2019 (copy enclosed) from AO(Pension) O/o. CCA Mumbai, wherein CCA has requested to this office to forward the pension cases with the required documents as mentioned vide Sl. No. 1 to 17. All controlling units are intimated to take necessary action accordingly while forwarding the pension cases.

Sub:- Pending pension cases due to delay in submission of pension cases from units – reg.

Ref:- CCA/MH-MUM/PEN/52 dated 27.05.2019.

Kindly refer above cited subject and letter under reference, wherein Dy.CCA, Mumbai has intimated to this office the details of pending pension cases mentioning the references right from December,2016 to March,2019; which shows inaction on the part of concerned units.

CCA Office has forwarded the list of employees (SSA/Unit-wise), who retired since April,2018 to April,2019 and intimated that the respective units still not forward the pension cases of these employees to their office (list attached). The non-action on the part of respective units resulted delay in settling the pension cases.

It may kindly be noted that, pension being sensitive matter, prompt action by the respective unit heads is expected, regarding submission of pension case to Pr.CCA office. However, it is seen that, timely action regarding preparation of pension papers as per Rule 58, stage wise completion of pension papers as per Rule 59, completion of pension papers as per Rule 60 and forwarding the same to Pr.CCA, as per Rule 61 of CCS (Pension) Rules in time, (not later than six months before the retirement of employee) is not being taken up by the respective units.

In case of non-settlement of pension cases in time, employees concerned many a times prefer appeal in court of law to get the relief. In most of cases, Hon'ble Court not only direct BSNL to pay the pensionary benefit in prescribed time but also instruct to pay the interest on delayed amount.

So to avoid any legal action in the case, every concerned authority is hereby requested to kindly pay his/her personal attention for early submission of pension case as intimated by Pr.CCA vide letter under reference immediately. In future pension case should be submitted to Pr.CCA within the time scheduled, as per Rule 61 of CCS (Pension) Rules.

It is also requested to kindly fix the responsibility of the official/officer , who are responsible for non-submission of pension cases to Pr.CCA in time, as listed vide letter even no.52 dated 27.05.2019 and initiate Disciplinary/Administrative action as deemed fit.
