Subject: - Processing of pension cases (SAMPANNA) for VRS optees under VRS-2019 Scheme.

As you are aware that pension cases of VRS optees are to processed and to be forwarded to CCA office in a time bound manner. Hon'ble CGMT as well as undersigned has been regularly perusing and following up with all BAs/SSAs to complete the process within the targeted time frame. A Google sheet has also been shared to all BA's to update the status on the daily basis. However, in spite of repeated follow ups and persuasion by the under signed, the progress is found to be very poor and disappointing for most of the BA's/SSAs. Hence a video conference is conducted with all BAs/SSAs under the Chairmanship of Hon'ble CGMT in presence of GM (F) & undersigned on 20/02/2020. During the said video conference the target is assigned on date basis to complete the entire work by 22/02/2020 and same has already been shared on SSA Head's whatsapp group. From the perusal of the said Annexure it can be seen that following SSA's have not completed even 50% of the total cases. This has been viewed seriously and these SSAs have been cautioned.
