

Treatment should not exceed CGHS rates issued by the ministry of Health Family Welfare, Govt. of India time to time. This approval is issued as per BSNL Corp. Office guidelines vide letter no. BSNL/Admn/I Dtd. 22.04.2003.

The SSA Head is requested go into an agreement annexing the required documents which are essential for settlement of medical bills. An Annexure has already been issued & circulated vide this office letter No. A/Admn-II/Medical Facilities/GuideLines/2011-12/88 dtd. 14.03.2012.

Unless the agreement is signed by both the parties (BSNL & Hospital), the hospitals will not be considered as empanelled. If the empanelled hospital is not able to furnish IT exemption Certificate issued by the IT department, TDS may be deducted from the payable bill amount.

After agreement is made, the empanelment of the hospitals may be conveyed to this office with copy, to CAO (OP& Mktg.) O/o CGMT MH Circle, Mumbai and also uploaded on SSA's website.
