

Subject: Common order dated 26.05.2020 in OA Nos. 150 to 154/2018 pronounced by the Ld. CAT, Cuttack Bench in the matter relating to regularization of RTP service-reg.

Sir,

Several officials have filed cases for regularisation of their RTP (Reserve Trained Pool) service period rendered by them prior to regularisation in various benches of Hon'ble CAT and these are defended by the respective Telecom Circles. Among these cases, CAT Cuttack bench has delivered similar judgment vide its order dated 26.05.2020 in the following four (05) cases:

- (i) Case of Shri Kunja Bihari Panda, OA No. 150/2018 before Hon'ble CAT Bhubaneswar.
- (ii) Case of Shri Uday Nath Panigrahi, OA No. 151/2018 before Hon'ble CAT Bhubaneswar.
- (iii) Case of Shri Rabindranath Mahapatro, OA No. 152/2018 before Hon'ble CAT Bhubaneswar.
- (iv) Case of Shri Kailash Chandra Panda, OA No. 153/2018 before Hon'ble CAT Bhubaneswar.
- (v) Case of Shri Chadnra Sekhara Sahu, OA No. 154/2018 before Hon'ble CAT Bhubaneswar.

Original Judgment is available on the website of Hon'ble CAT Cuttack Bench, which may kindly be perused. The operative part of these Judgment is given as under:

For OA No. 150/2018:-

“.... In the circumstances, the grounds advanced by the applicant in his pleadings do not have any merit to call for any interference in the matter. As a result, the OA is liable to be dismissed both on the ground of limitation as well as merit. Hence it is dismissed.....”

For OAs 151 to 154/2018:-

“.....In other OAs in this batch, same or similar grounds have been advanced which cannot be accepted in view of the discussions in the preceding paragraphs of this order in respect of the OA No. 150/18, which are also applicable to these four OAs. The relief sought for in these OAs are similar to the reliefs sought for in OA No. 150/2018. Hence, these four OAs are also dismissed for the reasons as discussed in this order for OA No.

150/2018. All five OAs in this batch are accordingly dismissed. There will be no order as to costs.....”

As other similar cases are pending in other benches of Hon'ble CAT at different stages and are being defended by the respective Circle, It is requested that Hon'ble CAT Cuttack order dated 26.05.2020 may be perused and brought to the knowledge of concerned BSNL Counsel. Depending on the facts of cases, if required then in consultation with BSNL Counsel this may also be placed before the Hon'ble Court.
