Sub:- Non-tenure/Tenure transfer and Posting of JEs(Circle Cadre) in MH Circle– Regarding.

As per approval of the competent authority, the list of JEs enclosed in Annexure "A" are hereby transferred to the SSA/Units shown against their names.

It is requested to relieve the official who is/are under transfer latest by 01.10.2020, failing which such officials will be relieved directly by Circle Office, Mumbai through ERP and disciplinary action shall be taken against the responsible officials including BA/SSA heads for not obeying of orders of higher office.
