Sir,

I am to refer to your letter no.BSNL/5-1/SR/2012/Vol.II dated 20th March, 2013 on the subject cited above forwarding therewith the details of total number of polling booths and the total no. of voters in each Circle for the secret ballot election to be held on 16th April,2013.

In this connection it has been decided that all the ALC's/LEO's in the field will act as observers for the work of secret ballot election to be carried out by BSNL Management. The Management is requested to contact Dy.CLC©'s/RLC©'s in the field in this regard. List of the Dy.CLC©'s/RLC©'s is enclosed.

Observers are requested to oversee that "free and fair" election (including counting of Ballots) held in the areas assigned to them. They are also required to submit a confidential report to CLC© endorsing a copy to the Chief Election Officer, BSNL immediately after the election. It is clarified that they will not associate themselves with the process of Secret Ballot Election. They may also contact CLC©/Dy.CLC©, HQ over phone in emergency cases. BSNL management will provide transport and other related expenses.
