In accordance with the provisions of sub-para (1) of section 22 of Industrial Disputes Act, 1947, it is hereby notified that the BSNL employees will go on two days strike on 20th & 21st February, 2013.


Demands

- 1) Concrete measures to contain price rise.
- 2) Concrete measures for employment generation.
- 3) Strict enforcement of labour laws.
- 4) Universal social security cover for organized and unorganized workers and creation of National Social Security Fund.
- 5) Stoppage of disinvestment in Central and State PSUs/Undertakings.
- 6) No contractorisation of work of permanent/perennial nature and payment of wages and benefits to the contract workers at the same rate as available to the regular workers of the industry/establishment.
- 7) Amendment of Minimum Wages Act to ensure universal coverage irrespective of the schedules and fixation of statutory minimum wage at not less than Rs.10,000/- linked with cost price index.
- 8) Removal of all ceilings on payment and eligibility of Bonus, Provident Fund and increase in the quantum of gratuity.
- 9) Assured pension for all.
- 10) Compulsory registration of trade unions within a period of 45 days and immediate ratification of the ILO Conventions Nos. 87 and 98.
- 11) Do not implement disinvestment in BSNL.
- 12) Do not bring VRS in BSNL.




