

Sub: Issue of Presidential Orders to Temporary status mazdoor upon their absorption in BSNL.

I am directed to invite your attention to DOT letter No. 27-2/2006-SNG dated 20.10.06 vide which decision of the DOT regarding issue of Presidential Orders to Casual Labours who have been conferred Temporary Status (TSM) on or before 30.9.2000 and regularized in BSNL on or after 1.10.2000 was conveyed. Accordingly, all the Circles were requested to send the list of such persons to DOT through BSNL C.O. for approval regarding issue of Presidential Orders to the eligible persons.

It has been noticed that such cases regarding issue of Presidential Orders are still being received in BSNL C.O. for onward submission to DOT for issue of Presidential Orders even without proper examination/scrutiny of the cases at Circle level.

It has been decided with the approval of the Director(HR) that all such pending cases regarding issue of Presidential Orders may be submitted in the prescribed performa latest by 31.03.2012. Further, a certificate in this regard duly signed by DGM(A)/GM(A) that no such case for issue of P.O. is pending in the Circle or in any of the SSA of the Circle may be furnished as per the prescribed performa.



OFFICE MEMORANDUM

Subject: Counting of past services of the Temporary Status Mazdoors upon their absorption in BSNL-reg.

In supersession to previous orders for absorption in respect of Temporary Status Mazdoors (TSMs), it has been decided that those Temporary Status Mazdoors who have been regularized in pursuance of this office letter no. 269-94/98-STN-II dated 29.09.2000 were to be absorbed in BSNL w.e.f. 1.10.2000 as per their status as existing on 30.09.2000. Accordingly Presidential Orders may be issued in respect of those Temporary Status Mazdoors who were having TSM status prior to 30.09.2000 so as to allow them benefit of counting of 50% of the TSM period for pensionary benefits. Related service matters of these TSMs absorbed in BSNL w.e.f. 1.10.2000 may be resolved accordingly. It is further clarified that in respect of those Casual Labourers who were not having TSM status as on 30.09.2000 and who have been regularized in BSNL after 1.10.2000, their status will be of a PSU appointee and therefore, no Presidential Order need be issued in such cases.

Prior to issue of Presidential Orders, the cases of eligible TSMs may be examined and forwarded through BSNL HQ for approval for issue of Presidential Orders. The individual Presidential Orders will be issued at circle level under the signature of the Director(Estt.) designated for the issue of P.O.
