**Sub :- BSNL employees Medical Reimbursement Scheme.**

It has been observed that in spite of several instructions the employees have not renewed their BSNL MRS Card and persons not eligible under the Scheme have enrolled as a dependent family members. The following persons are not eligible as a dependent family members as per the BSNL MRS policy and existing rules on the subject.

1. Family members who are no longer dependent upon the BSNL employees though staying with him / her.
2. Son starts earning or attains the age of 25 years or get married whichever is earlier.
3. Daughter starts earning or gets married whichever is earlier.
4. Wife of deceased employee appointed on Compassionate Ground are not allowed to avail the medical benefits/facility under BSNL MRS to their parents.
5. In case of female employees parents or parents-in-law at her option, if condition of dependency and residence are not being satisfied.
6. The income limit per month for dependent from all sources including pension/family pension and pension equivalent to DCRG exceed Rs.3500/- plus the amount of Dearness relief thereon.
7. Brothers and Sisters.
8. Family members (other than spouse) whose monthly income exceed Rs.3500/- plus the amount of Dearness relief thereon.
9. For the members not covered under BSNL MRS Scheme.

As per BSNL Corporate New Delhi letter No. BSNL/Admn-II/15-10/07 dated 16/4/2010, dependent under BSNL MRS for serving and retired dependent means and include self, spouse, two dependent children (if born after 16/04/2010) and dependent parents.

Hence all the Serving & Retired employees of O/o CGMT, BSNL, MH. Circle, Mumbai-54 are requested to renew their existing BSNL MRS card with a new one if the existing and card is more than five years old or there is a change of dependency of family members. Such employees are requested to surrender their existing BSNL MRS Card. They should submit the duly filled forms along with eligible family members photo of size 5Cms/7Cms.
